- 6. I have examined Plaintiffs' Exhibits 1 in the above-cited case concerning the business meetings of Solid Rock Church, Inc. as held on July 1, 1993.

- 7. Plaintiffs' Exhibit 1 is the resolution that was presented to the members for voting on at the July 1, 1993 business meeting of Solid Rock Church, Inc.
- 8. Plaintiffs' Exhibit 1 is the only resolution that was presented to the members for voting on at the July 1, 1993 business meeting of Solid Rock Church, Inc. Notice of the meeting was presented to the members for the sole and exclusive purpose of considering the name change from the Elk River Assembly of God Church to the name of Solid Rock Church, Inc.
- 9. In 1993, I believed that William N. Matthews was an honest man of integrity that would engage only in truthful activities.
- 10. In 1995, I did not feel that the organization was properly ministering to its members and I started to look for another place to worship. While I was considering other churches, I was still a member of Solid Rock Church. However, William N. Matthews sent me a letter in May-June of 1995 terminating my membership and stating that if I wanted to return that I had to come in and talk to him personally. Because the church had terminated my membership, I decided to not return.
