Notice of the meeting was presented to the members for the sole and exclusive purpose of considering the name change from the Elk River Assembly of God Church to the name of Solid Rock Church, Inc.
- 9. In 1993, I believed that William N. Matthews was an honest man of integrity that would engage only in truthful activities.
- 10. Plaintiffs' Exhibit 4 is the resolution that was presented to the members for voting on at the July 11, 1995 business meeting of Solid Rock Church, Inc.
- 11. Plaintiffs' Exhibit 4 is the only resolution that was presented to the members for voting on at the July 11, 1995 business meeting of Solid Rock Church, Inc. This was a quickly called meeting of the members by William N. Matthews who would not disclose the exact purpose of the meeting until after the meeting started.
- 12. The members of this non-profit corporation did not vote to give up membership voting rights and they did not vote on any Articles changes at the July 11, 1995 business meeting of Solid Rock Church, Inc.
